## **Introduction**

During the few days of which I have been writing this document, stories have broke in the UK media relating to the organisations behind what I have been fighting to expose now for 12 months. This though, is just the tip of the iceberg. The shock at seeing the treatment given, and the suffering of the young people who had initially expected help, by charities and foundations designed to help those suffering from gender dysmorphia is just the beginning. This is the start of unveiling a huge tragedy that has come across our society with many innocent people in West Yorkshire in particular experiencing abuse from the local authorities, working in coalition and in the knowledge that their actions are resulting in the incredible suicide rate in the area. That is a rate that has risen 50% in the last year alone, when that rate was already the highest in the UK as I have trying to shine light on for the last 12 months. Now, thanks to the ensuing investigation into and change in public perspective towards Stonewall and their sibling organisations I hope the following can aid in speeding up the bringing to public attention of just how far those organisations gone to alter society, not just by means of the treatment of those young adults which will lead to serious health conditions later in life, not just the propaganda that has hindered free speech in society and even more than what will soon be seen as an attempt from those organisations to instils the psychological suffering of gender dysmorphia into the minds of most of those children in the first place. You will learn where this has started, how it has infiltrated and spread throughout the organisations designed to protect our society and values and how it also relates to what can only be described as a social genocide by means of domestic terrorism. This needs to stop now before many thousands more lives are lost of children and adults who have been drawn into something so evil through no fault of their own. I hope that justice can be achieved by this information coming to light as soon as possible in order for me to be able to once more focus on what I love the most - improving lives.

## **Background**

We currently live in extremely dangerous and pivotal times. Social media and the access to any information from anyone anywhere in the world in an instant provides us with many wonderful

benefits as individuals and indeed collectively also. The internet allows for more views to be heard, it allows for political ideas to be shared, without censorship, and for groups of particular beliefs to form and grow rapidly in ways which the human race has never witnessed previously. It allows groups of people to present their cause, not only to those in their physical location, but to a potential supporter base that consists of pretty much every person on the planet. It has become a source in itself to gain power for individuals and organisations. Amassing a large supporter base for a cause today no-longer requires the slow growth through word of mouth and public meetings, whose attendances may gradually increase in size over time, as would have been the case for a growing political collective representing a new and alternative ideology years ago. Prior to the internet the initial focus may have been placed on producing magazines and pamphlets, the production of which increases as a groups resources grow, growing to eventually gain local press exposure and slowly increasing the awareness in surrounding areas, slowly adding more new members in the process. The ideas may eventually start inspiring associated groups to form in other localities, then, if successful, finally gaining national and then international media exposure. Prior to the internet, it may have taken years of public activity by founding members of a group fighting for a particular cause to gain enough supporters of that cause in order to reach the attention of the national media and thus a national audience. Unprecedented throughout the entire history of our species prior to this moment in time, it is now possible for that same level of growth to be achieved in weeks or even in a day with the right contacts and knowhow. Whilst on one hand this is indeed a massive benefit to humanity, and will become more so in a multitude of ways in the longterm, it also provides a basis for great harm to result from both intentional and unintentional propaganda.

It is wonderful for me to be able to access any scientific paper, knowledge from the best minds and writers in any area of my interest and its great for the next generations to gain education in addition to, or in fields other than what they are taught in school and college.

Yet, it is also just as effective for one who wishes to utilise those collective views to their advantage regardless of whether their longterm objectives are of benefit to humanity or otherwise. This may simply be a newspaper running stories on their front page as a result of it relating to what has been trending online and by this, I do not just mean solely the release of more content that is based on the topics of the greatest public interest, but actively looking for the next story

that would give the greatest appeal to its audience, by taking advantage of a trend of increasing interest. For example, let us say a horrific murder had taken place by a serving police officer on a person of ethnic minority or a female as with the Sarah Everard case, this would rightly cause a great deal of discussion and shock online. That discussion quickly becomes about ideas and all things related to the story too, rather than waiting for the paper or tv news to give more information, the public can bring similar stories from the past to light that may not have received the same attention before, the views of all can then be heard to those events too, ideas of prevention come up and can be discussed and anything a person finds online or has experienced that may relate to police brutality or brutality against females adds to the discussion. Quickly, this becomes a far broader debate regarding policing and even society as a whole, which in many cases can greatly serve to show where improvements can be made to our society. But it also allows for a veil under which exploitation and manipulation for a particular cause can be far easier to achieve. In this moment, from the given example, the media are looking for the next story relating to police officers abusing female members of the public and/or other wrongdoing and corruption, they are waiting for others to come forward who may have experienced police abuse in the past but had previously been unheard. Or of course, this can be seen as a huge opportunity to highlight one's fears over the safety of women and girls due to lack of concern from the police forces, which whilst of course is an issue in itself, what is happening in West Yorkshire at the moment is a prime example of where this manipulation can prove extremely dangerous. It allows for this to become the central focus, even if those cases are actually very rare in their nature compared to other issues, such as the safety of all on the streets, noting that far more men are victims of assault and murder than women, but also to ensure that the suicide rate in the area which is an anomaly compared to national averages is kept in the shadows. In fact, this propaganda, which can be seen by simply searching the internet for priorities of the West Yorkshire Police force, Tracy Brabins (the mayor of West Yorkshire) policing and crime plan or by scrolling through her twitter profiles (@TracyBrabin and @MayorOfWY) can cause even more harm to women and girls in the area by means of instilling that fear within them and thus ensuring that they really do become afraid to walk the streets in safety.

Yet over the most recent years of its existence, the human race as a whole has shown an increasing ability to emphasise, we now live in multicultural societies, care more for one another

with less perception of difference, see far fewer wars based on the need for a particular group of people to achieve resources by killing members of another and even something such as the increase in concern for animal welfare is a clear sign of that general increase in emotional intelligence and the ability to empathise increasing on average throughout the human population. This increasing empathy for one another has been dramatic in its rise particularly in recent decades and thus, not only is a more diverse and equal perspective of education passed from the parents and teachers to a young persons developing social character constructs but, it becomes increasingly valued as an attractive trait by others in society too. For one who understands the principles of Darwinian evolution it would be understood how that fact results in its provision, when displayed by an individuals character more so than the average person may display, of a survival advantage, thus concluding that the biological aspects too that may aid in an increased ability to display empathy and emotional intelligence are more likely to be those aspects that are passed on to future generations. These aspects may be the slightest variations between size and structure of an individuals glands, their brain structure and all that affects their hormonal environment and thus how experiences are stored and how a character develops as a result of those processes.

However, coming so far in so shorter space of time with regards to equality, can also mean that people may fail to witness that remarkable progress and thus, believe that actions, lawful and unlawful, are required to enforce a radical change on society; and that is what leads to new and greater divides being created. The only way to eradicate those divides as completely as may be possible, is to all individually, and thus, as a collective, live without any psychological trace of perceived difference. That is, for a generation to emerge who collectively do not have the slightest perception of any racial stereotypes, a generation that would be far closer to emerging than it would appear many radical groups seem to be aware of. For we live now in the final whisperings, those last two to four generations at most over which those discriminatory stereotypes will eventually completely fade out. This generation of young adults are not our grandparents or even our parents, we did not grow up in a time where on a daily basis only white skinned humans for a great part of their life may be witnessed by an individual for example. Note then also how males today display a far lower level of behaviour which is of dominance and thus oppressive to

members of the opposite sex. As is the case with humans as a whole when related to perceived differences as a result of race or sexual orientation.

When people have felt a traumatic amount of pain, be it from singular events of high trauma or/and by being exposed to daily events which are perceived as oppressive, there is often born a great desire to make a difference. This desire and ensuing actions can increase of course if there are others who align with a shared vision due to their own experiences of similar nature, let alone when those experiences are shared by their own kin and friends. That creates a shared value, shared ideas, philosophies and resulting actions that can best facilitate that burning ambition to create a change in society. Lack of control creates a desire for control, and a pain you may have felt yourself at one stage in life, due to its nature may have opened your eyes to social issues that are perceived as so horrific they need to be eradicated from society immediately, even if that means actions that result in creating more harm in the process and actions that would be deemed unlawful. A person can become blinded by those experiences to the progress that is already being made when not viewed from such a narrow perspective of the spectrum of time. That then can be a demand that consumes a persons thoughts, dictates their communication with others and thus, support and compassion may be felt. In turn, more speak of their experiences and thus, support groups, then organisations form, power and influence can be gained step by step.

However, power in the wrong hands can be extremely dangerous. In Germany, the Nazi party was by many, seen as a saviour as the 1930's begun and whilst their propaganda initially influenced public perception enough that a general perception was created through which, the Jewish people should not be trusted and are a different peoples to themselves. Yet, had the public known the ultimate plan to eliminate the Jewish people completely and the means the party would employ to do so, then the party would never have been able to achieve their initial power which in turn led to their complete domination of the country. Power in a collective who's beliefs are of such nature that there is a perceived enemy defined by racial and gender related characterises is an invitation for genocide and war.

## **Stonewall**

Stonewall, the LGBTQ charity which is pivotal in the influence over trans rights awareness and support, has recently received substantial amounts of bad press and social media outrage after suggesting that children know if they are of a different gender to that of their birth from as young as 2 years old in nursery. This is the latest of many messages the organisation has given out in recent years that have seen it lose vast numbers of supporters. The public is becoming aware that in recent times, despite the great work the organisation may have achieved in the past, scientific misinformation is being used to manipulate peoples beliefs, to serve ulterior motives and, many are now beginning to believe that Stonewall advises organisations through the training they provide by means of diversity development assistance, interpretations of the law that are in fact against the law and are not in favour of promoting equality at all.

Psychologically, gender is a social and environmental construct, it is only physical attributes that can be used to define sexual gender and this is where many feminists have been in opposition to their former allies who may believe that they were born with psychological gender traits and may say “we just know” in respect to why they believe that they are born into the wrong physical body. We will, all develop and store memories differently and particular physical constructs which dictate the specifically individualistic levels of each hormone released do vary, bot just by means of the obvious large variations between males and females, but the minute difference between every single individual of each sex. That is to say that no two humans have the exact same number or cells, molecules and all of the exact same atomic combinations within the make up of every organ of their body and thus, the natural hormonal levels vary and we all respond individualistically to experiences and how those experiences are stored within our memories. This does mean it is true, that a great deal of our balance between masculine and feminine traits, can be heavily influenced in a child and therefore should be considered objectively in education. There is though a fine balance between accepting that certainty of a desired physical gender change is known within an individual who has freely evolved that way from childhood, has been so for a suitable period of time, that they can transition if they desire to do so as an adult and a person who is simply embracing and exploring as opposed to repressing their masculine (for females) or feminine (for males) side.



The concerns that are being highlighted in this moment though relate to the influence Stonewall and its siblings still have and how that could potentially mean they would support the process of encouraging transition psychologically at any given opportunity, a concern that will be shown even more so in the coming months to be completely justified.

As a young child I can recall how I once saw a wedding dress with an extremely long trail on TV, it amazed me and I vaguely remember how my mum had to manufacture a trail somehow on a dress for me to wear at the time, something I know is not an uncommon experience to most male children. It is things such as that which we should be allowed to do and it is us, this current generation of adults, who can be the parents who do not discourage what the child may enjoy, regardless of previous stereotypes. That would align with a generation that has emerged where the subconscious beliefs ingrained are also such that a parent should have no fear of that child later becoming homosexual or even transexual. With regards to this generation more so than the last and less so than the next, it would not make any difference to most of us what sexual orientation or identity decisions our children evolve to embrace; and in the next few generations shall come an entire population with psychological indifference to their child's choices of natures such as these.

Stonewall now though, is being accused by many of attempting to trans the whole world and many of the organisations previous supporters from LGB communities highlight an attempt to coercively and covertly assist a transition of young adults, let alone possibly young children, when it may be so that those people were simply discovering homosexuality which in many cases would likely have been their developmental pathway without the added confusion from influential voices propagating doubt as to whether instead they are actually in the wrong physical body. On the extremest side, of which Stonewall and their sibling organisations such as Touchstone, Mermaids et al are clearly now a part, would it not be desirable to have alliances with teachers who may begin to act on signs such as my previously mentioned dress with a trail memory, and thus coercively encourage the child's development?

To understand what shall follow, please do take a moment to have a quick glance at the press articles I provide as understanding the recent sway in public perception, the suspicions that are beginning to arise regarding Stonewall's practice, its influence over partners and references to

advising civil organisations to implement practices that are unlawful is key to what shall follow. One particular area of interest being a manipulation of their position in accordance with shared agendas from Yorkshire MP's, police forces, councils and other authorities. The networks that may have progressed the furthest in this area due to its history and, prior to the tipping point, wonderful progressiveness in areas related to acceptance and diversity, have spread across the nation now and thus, this is why we are indeed seeing these stories in the national press.

On 2nd August 2022, the Daily Mail published an article with the headline urging organisation that are still associated with Stonewall to leave their initiative and it also highlights how the perception has shifted and that many previous supporters are now rallying against the charity: <https://www.dailymail.co.uk/news/article-11067585/New-push-stop-Stonewall-getting-taxpayers-cash-legal-battle-raised-fears.html>

The same article also mentions how both Liz Truss and Rishi Sunak in the midst of the conservatives leadership race, have both asked organisations to cut their ties with Stonewall. Another article, in the Spectator<sup>1</sup> gives some further details as to their inhuman and, as you will soon see, acts akin to terrorism are beginning to come to light. This article relates to the recent court case between the company and Alison Bailey who was unfairly dismissed from her employer, a Stonewall advocate, on the grounds of being transphobic for stating her understanding of science, in that a trans woman is not a woman as a woman is defined by their physical birth characteristics alone. In response Stonewall gave a reply that fits perfectly with their knowledge that they are training organisations to implement actions that are not always in line with the law but then wishes to ensure that they are not seen as responsible or held accountable for this - "Leaders within organisations are responsible for the organisational culture and the behaviour of their employees and workers. Stonewall's resources, support and guidance is just one set of inputs they use." The main focus of the article is on the recent announcement that the Gender and Identity Development Service (GIDS) clinic of the Tavistock Trust is to be shut down due to an investigation finding it to be prescribing treatments which have no scientific evidence to support their implementation, poor diagnosis's, poor record keeping and responding to any criticism by shutting down responses by means of responding to any accusations by suggesting the comment is transphobic. This is the same as the pattern of responses I

experienced myself after posting the scientific facts relating to birth genetics that deem it unfair for a trans woman to compete in female swimming events. Of course, of the six other clinics that are known in the UK, it did not surprise me to see that two of these are in Yorkshire, with one in Sheffield and another in Leeds<sup>2</sup>, and that is not accounting for the vast array of charities that have formed in the Yorkshire region who command the greatest influence over these clinics. For me, these stories and public awareness of the actions they present comes at an ideal time as it relates greatly to what I experienced my self 12 months ago and have spent a great part of the previous 12 months investigating and fighting to achieve justice for, not just for myself but for countless others and hopefully bring an end to what in West Yorkshire at least is already resulting in what can only be described as a genocide.

### **The Leeds and West Yorkshire Influence and the Fuhr-her**

The relation to West Yorkshire and Leeds in particular in respect of its central position, not just in the UK but around the world for feminist culture and notably the most extreme forms of such, its diversity in individuals from varying ethnic backgrounds and sexual orientations is well known and of course much of which has been a great thing for the area. Once more though, that also means that a suitable veil is provided under which the evil agendas too can play out. I must also state that the diversity and culture was one of the most appealing aspects of the city koto myself when I chose to move here five years ago. At the time though I was unaware of a great deal of the history and especially the links with radical feminism, not restricted to the Revolutionary Feminist Group and their ideals of a male free society as shown in the Republic for Modern Life videos, but the great deal of progression since those times, something I touch on within those videos too, so I will not do so again here. I mention touch on, as the Republic for Modern Life presents a story

aimed to initiate an investigation and does not give even the tip of iceberg as far as the research I have amassed over the last year is concerned.

You will see from much of my content recently, including the Republic for Modern Life that I have been attempting to raise awareness to the fact that the West Yorkshire Police force, under the control of the Deputy Mayor for Policing and Crime, Alison Lowe, are acting discriminately and unlawfully by abusing and harassing predominantly white heterosexual males, although there are many female victims too, by presenting an inconspicuous barrage of lies and cover-ups followed by harassment from local mental health services too, more on the links there to come. But just to complete that small digression, it does not take much insight to imagine how someone who is known for their work in the fields of which I am, including the successful podcasts and reputation for helping others overcome their mental health challenges, would feel not only such a huge insult to my intelligence for one, but to experience a consistent and never ending internal pain by seeing what I was subjected to from those combined authorities. These are the same authorities who only 6 months previously had commended by informing me I was to receive a police commissioners award for bravery following an attempt to save someone else's life after I jumped into the river Aire and managed to locate them and get them to the shore. This play of corruption though, like the experiences of others, was not even done with an attempt to make me question whether something strange was going on, it felt more like they were letting me know "we are completely aware that you were the victim of a horrific and serious crime but look, we aren't going to help and if you persist we will subject you to more abuse as quite simply you have no means to complain as you will soon find out, so we know we can get away with it." Whilst they were correct as my IOPC emails will show, in that this network of institutional corruption would mean that I had no means to achieve justice, that insult to my intelligence stayed with me and that meant I had to know how, what and why this would happen. It is that which has led to what you are reading now, for when I saw the links initially to a larger agenda that relates particularly to the history of Leeds and the surrounding region, and thus why the suicide rate of the city is double that of London, and that West Yorkshire is the county with the highest national rate by far, my objective was no-longer personal justice, but stopping what has become what can only be described as genocide via an act of domestic terrorism.

Last year of course was before the national awareness had grown with respect of the gender politic issues which are now coming to light, for this as well as the war on white privilege and male violence all link in with mutually aligned agendas.

### **Fragmentation of the left by way of Gender Politics**

I highlighted previously articles that have recently been in the press relating to gender politics and I hope that serves as a sound foundation for what I will attempt to describe in this section, for the area of gender politics is not my own area of expertise however, a lot of it does relate to psychology and now it has become clear that the recent divides that have seen formations of new LGB alliances, as well as feminists, by way of now being in opposition to the LGBTQ+ transgender politics systematically relates to the same practices, philosophies and corruption mechanisms that were at play to irradiate the white privilege from society.

Stonewall and its sibling groups had in the past done some incredible work to ensure a greater understand of the challenges faced by people in the LGB and ethnic minority communities but now there politics have changed and not only have their politics changed, but they are in direct opposition to the science backed philosophy that the LGB community and feminists have understood for years. That being, that gender is a social construct and not something we have implemented as a psychological difference from birth.

At birth we are born with a blank state when it comes to our psychology and I will leave a greater understanding of that principle from this paper as I have covered it previously in podcast episodes and elsewhere, and indeed that is well documented in scientific literature as well as many feminist writings. The Republic for Modern Life video series gives a great background there and one of the Leeds Revolutionary Feminists who I would suggest paying attention to further is Julie Bindel who features prominently in my documentary as well as on the BBC's Angry Wimmen documentary. The Angry Wimmen documentary discusses the most radical branch of feminism that developed, yes of course that was in Leeds, the home of the most extreme forms of feminism, feminist research and now transgender and queer theory work. Julie for one, is in great opposition now herself to organisations such as Stonewall, Touchstone and Mermaids et all, as she even states in the documentary how political lesbianism was aided by the fact that gender is

a social construct. Note that in being a social construct it means that our masculinity and femininity, sexual fantasies, desires and psychological gender can be influenced by specific methods of psychotherapy. That is something I have experienced by means of coercion myself, it is indeed related to the most effective methods of psychotherapy implemented in conversion therapy too.

A recent article in the Times<sup>3</sup>, presented as a front page story, highlighted how many universities had banned a great deal of literature from their reading lists due to the potential emotional harm that they may cause students, one of Julies works was indeed one of these as the concept of gender being a social construct is in direct opposition to the agenda of Stonewalls transgender politics by way of that being harmful to a transgender person as they may indeed realise that their initial belief of being in the wrong physical body is in fact not something that was already within their psychology at birth. Yet, that is simply what science conclusively shows and thus, Stonewall et al, have created their own means of pseudoscience in order to mask this and attempt to show the opposite.

Incidentally whilst I have mentioned the Republic for Modern Life and the BBC documentary (both can be seen in full on youtube), it is worth noting here too that another of those interviewed is a labour MP residing over the Headingley constituency, Alison Garthwaite. Whilst I do not have evidence of any wrongdoing per say by Ms Garthwaite, she does openly express how she was involved in the Leeds Revolutionary Feminist groups and their politics to create a utopia society that is free from the male sex, she discusses how reproduction was not a concern at that time due to the advances being made in science and the open theme throughout is that *all* men were seen as the enemy. She also discusses how they would reside in women only housing and would even go to the extents of throwing out any literature they owned that was wrote by male authors.

As you see in the Republic for Modern Life documentary, the Headingley constituency is next to the Kirkstall constituency which is held by another labour MP, Hannah Bithell, who indeed too has LGBTQ+ and the (her/she) pronouns on her twitter profile and the next constituency is Armley which of course is that held my Alison Lowe. Consider the quotes mentioned by Alison Garthwaite though and the perception of all men being an enemy, would this not be akin to

offering Heinrich Himmler political power (if he of course were still alive) in the 1970's and suggesting that although he had dedicated much of his life to the adherence of philosophies that promoted a society free from Jewish people, it is now forgotten? Again, I will emphasize that I am not presenting evidence of wrongdoing by Ms Garthwaite specifically, although close ties with Alison Lowe are not hard to find, but still, the thought is an interesting one and those political views are completely inline with the criminal acts that are being played out today thanks to the political and corporate power obtained by many in the decades since the conception of the Leeds Revolutionary Feminists.

Returning though from the digression, this is taken from a recent article on the Spiked website, the author is Kate Harris who is a founding member of the LGB Alliance, a charity that supports the rights of the LGB community and despite Stonewall, and their sibling organisations, claiming due to their psychopathological desire to insinuate anyone who disagrees with their pseudoscience as transphobic, or when applied to a ethnicity context - racist, the LGB Alliance is entirely supportive of the transgender community as well. They support freedom of choice and the rights of all people but they are entirely against, and rightly so, the agenda to "trans society" by allowing the incredibly evil practices of those organisations to encourage the psychological development of children, effectively via coercive practices, to believe that they are in-fact the different gender to the gender of their birth and rightly state that this is a scientific impossibility. The statement from this article though should articulate this point adequately for me to continue:

"And they mean what they say. When gender ideologues chant 'No LGB without the T', 'transwomen are women' and other slogans they are explicitly denying the reality of biological sex – the very basis of same-sex attraction – while demonising LGB people for daring to organise in defence of their own rights and interests."<sup>4</sup>

The article also touches on the issue this has caused regarding the enjoyment and love of the Pride events for many homosexual people who have felt attacked by the organisations that they rightly believed were created to enhance their own lives and aid with social justice. This was something I myself felt too on seeing the event this year; the Leeds Pride taking place directly

below my apartment and no-longer could I witness it with the same perception of an incredible day filled with mutual love and at this stage celebration for the successes the event and organisations have achieved throughout the years.

One thing that did strike me was that Alison Lowe had her own stall, I am not sure why and did not stop to look closely but I did notice it had a large banner stating “Alison Lowe Deputy Mayor for Policing and Crime” and this stall was directly opposite another that was offering merchandise with slogans such as “send nudes”, and perhaps worthy of note here too is that Alisons son Adam Lowe, who himself although identifies as gay, has been a prominent figure in the LGBTQ+ community and I believe the proliferation of Queer theory as an author and activist, does often perform in drag under the name Beyonce “Holes”. Whilst it should go without saying that in isolation there is no issue with any of these points and from the little I have seen he seems himself like a genuine and intelligent person, when we consider that Alison has been very outspoken in her views that actions such as cat calling from males to females should be banned and made a criminal act, the advocacy of similar rhetoric from others who do not identify as white heterosexual males does seem somewhat discriminatory. I would also like to add a personal injection here in that on moving to Leeds and prior to my own experience of being subjected to covert emasculation by means of a coercively controlling and abusive partner and thus, prior to losing 40-50lb of muscle during that time, a day would not pass where I would not experience females whistling or “whit wooing” in the street and often even (usually but not always after asking) feeling my abs or biceps. To me, that was normal and complimentary even if it could at times be irritating, but I do wonder if I would be encouraged to report such incidents in the same manner as which a female is now encouraged to report wolf whistles or similar acts they may be subjected to. I highly doubt it.

Of course, with a personal bias as a result of their own personal traumas that have not been psychologically healed and are thus allowing a catastrophic level of discrimination within her politics and the highly unlawful application of those political ideologies through the police force and other authorities, this inconsistent behaviour has become expected. A little research will show that Alison Lowe and Touchstone, the organisation of which she was CEO of for 17 years prior to taking up her post as the Deputy Mayor for Policing and Crime are integrally linked with Stonewall, not only by means of numerous awards from Stonewall, which include Alison Lowe



receiving senior executive of the year on multiple occasions in addition to awards for Touchstone itself, but by representation at events, associations with other leading executives and the fact that Touchstone operates to the exact same philosophies that underlie Stonewall. The implementation of safeguarding policies is a key example whereby the two companies work together in order to achieve objectives and the Stonewall safe guarding policy document<sup>5</sup> is an extremely interesting read for anyone who has experienced the combined efforts of the police and other local authorities, then immediate harassment from mental health charities in order to avoid details of individual experiences of corruption and police abuse from coming to light. The co-operation between such organisations firstly, allows networking between those organisations and the person of whom they deem aligns with their characteristics of people which demand protection, victim or perpetrator and to discredit, whilst attempting to torment into silence or destruction, the person whom represents a group of peoples which they wish to eradicate, or a person who may desire to fight for justice and thus exposing the systematic corruption. Of course, where applied lawfully in order to assist victims, these networks can be of great success and thus, why they have been allowed to develop initially with government support and understanding. However, what we are witnessing now, especially since the complete power of the West Yorkshire Police force, by means of also transferring to local control the power over the organisation that's purpose is to investigate their actions upon complaint, the IOPC, was handed to Alison Lowe is the use of those networks to protect a person who it is believed falls into her categories of those who have either been oppressed or marginalised in the past and to abuse those who she perceives to represent groups that have had the privilege of a supportive police force in the past.

At this stage, I am going to share quotes or passages either by, or relating to Alison Lowe along with the sources to the full articles that have appeared in the Yorkshire Evening Post, in order to highlight the clear personal bias of this individual that is resulting in the horrific treatment and ensuing suffering of so many people by means of her discrimination against them in accordance with this revenge agenda. Of course, there are many of those who have not survived and thus represent the explanation for the substantial differences in the suicide rates between this area and other parts of the country.

It is telling that Alison considers herself lucky not to have faced racist remarks, although the same cannot be said for attacks based on her gender or views. "Absolutely I could have had people resorting to [comments on] my race," she said. "I've been so lucky that not one person has used the 'n word' on social media. I have to say that it doesn't stop them writing to me to say that though. "I've had a lot of stereotypical gender stuff. I had 'man hater' because I always operated from a feminist stance." More recently, her support for the rights of trans and non-binary people has attracted attacks on social media by what she describes as "very powerful lobbies" with opposing views. "When used sensibly and sensitively, it can be a thing of great power and beauty. It's just a shame it's not always so."<sup>6</sup>

A review of the statues in Leeds which was ordered in response to Black Lives Matters protests has found that they "over-celebrated Empire, Christianity and 'great' white men". Ms Lowe said: "I was surprised there were so few people wanted any change. I thought it would be a 30-70 split or 40-60 and I worried about that at the beginning because if there was no clear feeling it would be hard. As a panel we wanted to do the right thing by the majority of people and only 10 per cent wanted some active change. I know thousands did not (respond) but we had to take it that they were happy with the status quo."

She explained: "For black people we live in a world where white voices and white faces and white names predominate. We don't like it but there is too much for us to spend our lives looking back saying why is that like that. Leeds is built on the back of lots of people who don't get a say in power and are not acknowledged."<sup>7</sup>

"Fear of everything from my childhood came rushing back"

Division caused by Brexit undid several decades of work to eradicate racism and left the woman who became the city's first female black councillor too scared to visit the supermarket. Alison Lowe said she felt scared and backed off from engaging with people

for fear of having racist remarks shouted at her in public. However, as she speaks to the Yorkshire Evening Post as part of a series of features to promote Black History Month - she reveals that for the first time she is hopeful for meaningful and real change in what has been a world of 'white privilege'. She recalls: "I remember going to Morrison's after she told me and I was proper frightened. I had my head down and did not look at anybody, normally I would be chatting away, but I did not look at anyone. I felt someone would say something racist and I could not bear it. "That fear of everything from my childhood came rushing back. I completely disengaged from people around me and that lasted a while." "We have started a journey but if it was Leeds to London, we are not even on the motorway yet. We have got a long way to go."<sup>8</sup>

Speaking at the launch Deputy Mayor for West Yorkshire, Alison Lowe vowed that all men involved in "unacceptable" behaviour towards women would be dealt with. "Violence towards women is unacceptable and all perpetrators will be dealt with." she said "We need men to stop hurting us and we must take our power back and put an end to the toxic masculinity that has put women and girls at risk."<sup>9</sup>

West Yorkshire's deputy mayor for policing has said she fears transphobia has become "fashionable", amid a rise in hate crime against trans people. Allison Lowe, a long-term advocate of trans rights who became deputy mayor last year, said she believed online hate was helping to fuel the rise. Bradford councillor Richard Dunbar described the figures as "massively worrying". He cited research from the LGBT charity Stonewall which suggests more than a quarter of transgender people have attempted suicide, while 90 per cent have considered it. Ms Lowe, a former Leeds councillor, responded: "It's something that's very close to my heart. I've worked alongside Trans Leeds for around 10 years.

"I am really disappointed to see these figures, but not surprised. "It's become fashionable to be transphobic. There's lots of negativity online and I think that's driving some of these

increases. “It’s right that we see what we can do to support those communities more and better.” Ms Lowe said West Yorkshire’s mayoral office was looking into more ways to financially help LGBT and anti-hate causes. She added: “Our funds aren’t unlimited but I think there’s more we need to be doing. The police are really open to understanding how they can improve their responses to offences affecting the LGBT community.”<sup>10</sup>

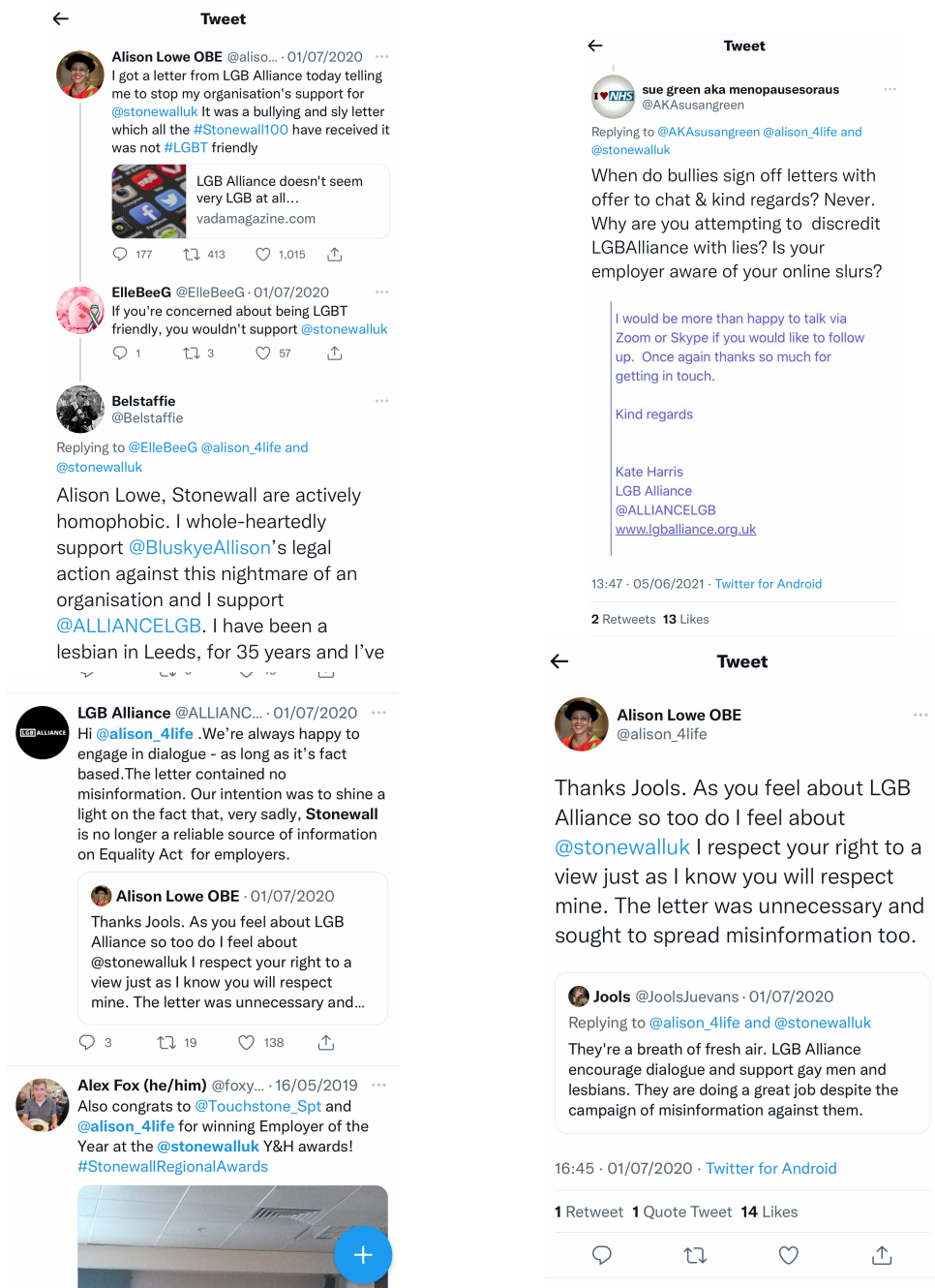

Hello Alison and sincere thanks for getting in touch.

We wrote to you in order to let you know that unfortunately Stonewall is giving information to employers like you which misrepresents the Equality Act. This exposes Touchstone to potential legal challenge and reputational damage.

When I was Vice President at American Express I made sure that our company took part in the Index. We made it into the top 100 and were proud to be represented. The problem is that Stonewall has changed significantly since 2015 and, much to my personal regret, are now giving out incorrect information on the law to employers, schools, universities and politicians.

Since March 2017 I have been speaking with Ruth Hunt when she was CEO, and then Jan Gooding as Chair of the Trustees, asking for respectful discussion on the direction they have taken. It is the view of many former Stonewall supporters, trustees and one founder that Stonewall has, regrettably, lost its way. Our goal is to help Stonewall get back to the once highly respected organisation it used to be; an organisation whose advice can be relied on 100%. Sadly that is not the case at the moment.

I am not sure exactly what you mean by being "trans positive" but I believe that our trans supporters would not be working with us if they did not feel that they were welcome in LGB Alliance.

With regards to this last article, it would be important to consider the obvious factor for this dramatic rise and that this has occurred in the time since Alison Lowe took up her role as Deputy Mayor for Policing and Crime. Please see the combined tweets shown in figure 1.

The actual emails Ms Lowe has described as bullying can be seen in figure 2, consider too the recent video clip which drew national attention of a former army veteran being arrested by five police officers for posting a tweet which had caused anxiety, which is the result of the adherence to the Stonewall laws being prioritised by the police that resulted in the Hampshire Police force withdrawing its funding to Stonewall. With that being the result of these initiatives spreading from West Yorkshire to other forces over the last year, it is not hard to imagine the sort of incidents that Alison and others are frequently, and by that I mean on a daily basis, urging those from her protected groups to report. It would only take a quick twitter search for "@DeputyMayorPCWY hate" (without the ") to see the reason for this dramatic increase and of course, now these figures have been published it serves the agenda of making it a larger issue in the minds of the coerced public and media. Note too, from the news report quotes I have given, the quote where she states that if it were Leeds to London, we are barely on the motorway. Well, they have flown down that motorway in the last year!

It is interesting to note too, that whilst writing this section I listened to an interview with Alison on BBC Leeds radio from earlier today (11th August 2022) in which she states how she has issued a wage increase to the police force to support the needs during the current economic issues which are prevalent throughout the country. She mentions though that it is the new recruits who have seen an increase of 8.8% and yet those who have served for longer and are more likely to have families and mortgages have only received a 3-3.5% increase. Of course, due to the recruiting strategy, it is those newer officers who are more likely to be happy to abide by her agenda and priorities even where those instructions break the law and I may be missing something here, but would that not be the only reason for giving such a difference in increase to the benefit of those who one would think need it less?

"I thought I was a good person with strong values, promoting equality, campaigning for women rights etc but in reality I was in turmoil."

"I internalised that pain, internalised that trauma (referring to the experience of being raped at 5 years old), so much so that my behaviours as a human being were not inline with my values."

"It not only led me to be a person that I did not want to be, I was angry, I was in rage."

"I went too far, I didn't understand that my quest for control, my need for control became an abuse, became twisted because I was so desperate not to be victimised again. I had no honesty about that, no insight about that and nobody would tell me because of course I was all powerful and that power was being abused."

"It meant that I could understand the impact of trauma on my life (referring to receiving counselling herself) but also how I was traumatising others."

The reason for providing this context on Alison is the reason my personal experiences tie in with the Gender Politics and Stonewall et al. For when I was communicating with the IOPC (full email correspondence will be published at the time you are reading this), I became aware of who was in control of the force and also, and somewhat unbelievably, the IOPC complaints relating to the same police force and quickly realised that my later emails were not being dealt with by the contact representatives alone, but being seen by Alison herself. At that stage, in my final reply I did say, without any mention of her previously by myself of the contact representatives, that if Alison would like to speak with me herself directly then she will know how to contact me. Within 20 minutes of sending that email Alison Lowe followed me on twitter, but as you will have seen in the final episode of the Republic for Modern Life, decline my invitation to talk.

## The Mermaids Charity Horror

It really is incredible how the universe works to your favour when you are pursuing something that is for the greater good and of great importance to you! For following the recent media coverage of Stonewall and of course being already aware of the links to the organisation with Alison Lowe, Touchstone and infact a great number of organisations in Leeds particularly, as well as wider Yorkshire, and the recent news relating to the ordered closure of the Tavistock Gender Identity Development Service, and too the content given by the LGB Alliance relating to their charity being taken to court by the Mermaids charity for their “anti transgender” views I was led to look further into the Mermaids charity and last night was in complete shock at what I discovered. Of course, with my background and work relating to the human endocrine system in particular<sup>12</sup> I was horrified to hear that these clinics were not just using the psychotherapy techniques in order to coerce children who had begun to question their gender in order to direct them towards identifying as non-binary or transgender, but that they were giving children as young as 10 years old hormone blockers!<sup>13</sup> The incredible synchronicity though is that as I have been writing this today, it appears I was not the only one undertaking this investigation (well, actually I know I wasn't due to communication I had with someone a few weeks ago, who coincidentally is mentioned as the first to post on twitter that the news was coming - you know who you are, thank you!) as this evening, stories have broken outing this tragedy and the involvement of the Mermaids charity by means of not only their scientifically incorrect, but extremely dangerous advice and actions that have been taking place over recent years.

When there is no scientific evidence, and never will be as gender is a social construct, to support Stonewall's claims that children as young as 2 can *know* if they are of the opposite gender to that of their birth, this highlights the disaster that has unfolded before us. A disaster resulting from encouraging non-binary perspective teaching to such young people as opposed to a modern

teaching stance which should be employed to show that it is perfectly natural for a child to experiment with their views and interests, that it is as normal in society for a person to identify as a gender other than their birth gender if the conversation arises, or as normal for a person to experience attraction to the same, both or even no sexes as it is to be heterosexual. I expect that this is what the civil organisations were led to believe that these coaching services and policies were designed for, so that the next generation of adults grow up without prejudice and discrimination, installing beliefs that a child should not be ashamed of their body as it is perfectly normal to be attracted to girls and to still grow breasts or to be attracted to girls and develop breasts later than their class mates. In such a society there would be no need then for those children to see their beliefs, attractions, orientations or body as any more acceptable or not than another and thus, over time we develop a complete society that does not leave that psychological imprint causing a child to believe they are different, that they should be ashamed of their body or perceptions, whatever those evolve to be.

In many males for example who do embrace their feminine side, that should be seen as normal too, as normal as it is to pursue stereotypical male activities. I hope that as these stories progress, and then that the evil side is stopped, and then that the culprits brought to justice, it can then lead to a better understanding of what has caused the radical extremist ideologies to form in the first place. An understanding that is, that would make a female with masculine traits proud to be a female with masculine traits, so that they embrace that aspect or, at least may receive the appropriate mental support to help them accept who they are and how their body is developing. With that understanding too, the mental health of the individual is better anyway as a result of their friends and classmates not seeing their desire to follow a certain appearance by means of choice of clothing, choice of activities, bodily development as something that makes them “different”.

Likewise too for children of ethnic minority groups, or of same sex attraction etc, and over time all those differences would not be seen as any different to a difference between having blonde or brunette hair. Hair colour being a good example here to clarify this point, in that those with ginger hair in childhood may have experienced discrimination at times as a result, though I believe the general psychological evolution of society has been able to reduce, if not completely eliminate, even those occasional childhood experiences of discrimination. Children today, as a

result of the environment they grow up in, specifically those who influence their psychological development - their parents and teachers etc, do generally have more empathy for one another, and thus less desire to inflict pain for perceived difference, than my childhood generation. Similarly, my childhood generation would have a far greater level of empathy and perceived equality to all than the generation of children to which my parents would have been a part. As a result I am sure that it is far more likely today that a childhood bully who attempts to discriminate for any difference is far more likely end up being the one who is then isolated and suffers as a result, due to the higher empathetic intelligence of others, than the person they are choosing to discriminate against.

We can see these positive influences all around and that is why this is such a fragile subject because organisations like Stonewall have in the past done a huge amount to benefit equality and that is not to be denied simply because of those who have twisted the objectives of the organisation in recent years. Consider the differences in what a child is exposed to today by means of television or the added exposure of the internet too, they develop with a far greater understanding of various appearances, beliefs, ethnic cultures without prejudice (although yes, some may still exist for now) than they would have been exposed to even as little as 20 years ago. With that change in influence, in tandem with the change in influence from their parents and teachers, they do have far more empathy for one another and far less perception of difference than previous generations.

But the issue has become one whereby a male child who comes into school one day with a Care Bear (I know I once owned one myself and wanted one when my sister had many and we enjoyed watching the TV programme together), would then be encouraged to play with the toys we would associate with girls, rather than have the freedom to take their Care Bear over to the area with the He-man toys, or to go to play with the barbies if they chose to do so. That freedom should be encouraged, but to then know that a teacher may have received coaching aimed to wrongly let them believe that is a sign of the possibility of that child being of a different gender to their birth at such a young age, when the child is simply happy and exploring, then leads the child to questioning things that they would not otherwise at that age. That questioning leads to contact with organisations such as Mermaids who in turn it appears would be giving information to make the child believe further still that they are not the gender of their birth. As this process continues,

they are being filled with beliefs that they should then start altering their appearance, beliefs that lead them to perceiving their body as being wrong and thus inducing a self-hatred towards it, beliefs that have progressed from simply having the freedom to enjoy what they wish over time have led to them experiencing gender dysmorphia.

In reality, without that intervention and coercion, that child may have evolved to embrace more masculine traits over time, they may have evolved to embrace more and more of their feminine side also. They may then have grown to love that they are a male who expresses a great deal of femininity, they may have grown to experience same sex attraction and embraced that or they may indeed have grown to believe that they would be happier if they were to transition their gender identity once they have that full awareness and understand as an adult where the risks involved can be comprehended. Given freedom though, and in a society without prejudices, which should be the objective here, they would not suffer with who they are, they would not have regrets later on and they would not come in contact with the horrific organisations that only serve to make them truly believe that they are different to others and thus the mental health issues that follow as a result, let alone the serious health issues that would follow by means of the hormonal interventions!

The GIDS NHS research page is clear eye opener in itself too and I would suggest further reading<sup>14</sup>. Although I have not taken the time as of yet to completely dissect every detail of the research they attempt to present (I would be happy to do so if called upon for discussion), I have seen enough for it to be very clear that even this should present a clear red flag! The science appears to be based not around a scientific understanding of the human body and the endocrine system, or a science backed psychological understanding, but predominantly upon surveys conducted to correlate the views of those who have transitioned or at least experienced gender dysmorphia. A correlation of a few select people does not signify a wider causation and that is a key factor here too, without wanting to appear against my belief that an adult should absolutely be entitled to transition should they wish, there are always going to be outliers who have a correlation of stored experiences, their psychological imprint of memories, that create a character that suffers from gender dysmorphia as a result. But none of those psychological factors were present at birth. Science has proven this to be the case conclusively and I would suggest

listening to the episodes of my own podcast as mentioned relating to this topic for any further clarity if required<sup>15</sup>. With that said, the following quotes taken from the aforementioned evidence page on the NHS GIDS site should really bring attention to the issue with hormonal therapy for minors, considering the objective of this page is to give *supporting* evidence:

“Although hormone blockers and cross-sex hormone treatment are recommended in young people with GD and widely used across the board, it should be noted that the research evidence for the effectiveness of any particular treatment offered is still limited.”

“Safety concerns remain regarding the impact of physical interventions. Although puberty suppression, cross-sex hormones and gender reassignment are generally considered safe treatments in the short term, the long-term effects regarding bone health and cardiovascular risks are still unknown (Cohen-Kettenis & Klink, 2015; Klink et al., 2015).”

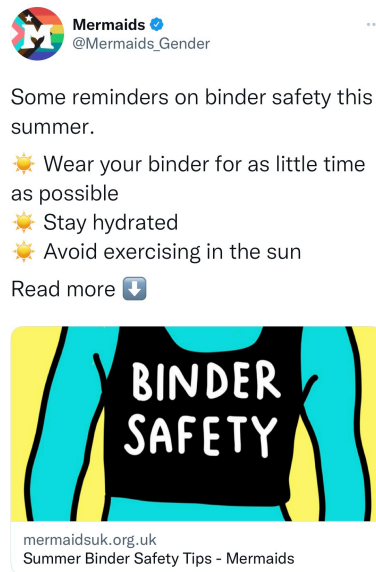
Let me momentarily regress back to the fact that evidence provided by the GIDS clinics, Mermaids et al, is based upon opinions and experiences as opposed to actual science. Considering the dangers of which are known with the use of waist trainers that have fortunately resulted in a reduction in their use by adults notably those in the fitness industry where they previous were extremely popular for a short period, to learn that these are given to children and often free of charge by these charities brought another huge shock. In a growing child, a binder, and note that they are prescribed for use for 8 hours a day, can cause serious damage too. It is one thing to know that something feels uncomfortable but does aid in the appearance of breast size being reduced, but these children are still growing! Consider the damage therefore not only to the breasts themselves, but the potential damage that could be inflicted on internal organs. These, like the rib cage are growing throughout adolescence and without the complete ability to grow outwards, it provides the potential to decrease, as opposed to increase the size of the chest cavity as bone growth continues. Once more, it is not only the immediate danger that can be caused whilst wearing one that is to be considered, but the potential for longterm damage that would result in extremely serious health issues. Of course it can only be a hypothetical judgement, but I would expect that without the coercive education I have discussed as a result of these organisations like Mermaids, then I would have expected that the child in question in the Daily Mail article may well have grown up to simply have become a lesbian and eventually proud to be so in her own body. Yes, it is true that she may well have had to experience other mental challenges along the way, challenges we all face with various insecurities as young human beings, those challenges though as I have discussed are becoming less prominent as we continue to evolve psychologically with a rapidly reducing collective perception of “difference”.

### **Where next?**

I have more to add and will endeavour to do so if and when required and time permitting, but I am also very conscious of the predicament that I am currently in at the time of writing. That is, and I hope what I have provided is substantial enough for my fears to be justifiable, one where I am working from within the epicentre, from the location of which I know the police and those mentioned in this paper will stop at anything to stop justice being achieved.

Consider that in the months that followed my initial call to the police, a call in which the operator on the 101 line instructed me to go to the police station immediately after hearing my story for around 30 minutes as the crime sounds horrific, I have been harassed and abused by them in order to attempt to silence me and prevent the course of justice. The IOPC emails and initial story I have wrote which covers the day on which I attempted to report the crime will show this in more detail for now. But for now I will just state that despite being on the receiving end and thus, attempting to report a domestic abuse case, which in reality could have cost me my life and has still seriously harmed it in many ways including my physical health, and when this was harmed further by the actions of the police I expected to protect me resulted in a heart attack. Something which I was informed by the doctors meant I would never be able to train the same

way in which I had previously and despite a second occurrence and hospital stay a few months later has never seen me receive the followup checks of which I was informed would need to be carried out every 6 weeks.

Like the experiences of others, any attempt to which I made to be able to report the crime to the police resulted in further abuse and then calls and harassment from mental health services. Of course, this is a result of the liaison and diversion operation from Touchstone that is inline with the Stonewall safe guarding actions. Actions that were designed to aid the support of victims and yet, instead are being used under Alison Lowes instruction to discredit and harass those who she deems not deserving of justice and police support based on her discrimination against anyone of stereotypical white privilege. Irrespective of their character, it is time for those to suffer the same way in which minorities like herself, her children or others such as David Oluwale had suffered in the past.

Consider too, that the last big piece of content I released relating to these experiences was a video in which I am showing my own psychological understanding of her psychological issues that would cause such behaviour<sup>16</sup> and attempting to help, resulted in another police visit a few hours later at 11:15pm. On this occasion, I refused to allow them to enter and through the doorbell audio receiver they were insistent due to a concern for my welfare raised by someone after seeing that video on YouTube. Watch the video and assess my mental state for yourself, I am pretty sure I do not seem suicidal. Of course, they knew already that I wasn't showing any signs of any mental health issues, let alone being suicidal, but once more were attempting to harass and abuse using concern for welfare as an excuse to do so.

I have spoken with others, who have experienced even worse and whilst I must admit that a level of excessive fear, or paranoia, is natural when experiencing such treatment considering the complete control of civil authorities in the area by Ms Lowe and collaborators, it does mean I am aware that my life is indeed at risk. A risk that I have no choice but to take in order to do what is right and just. I expect that it is the knowledge that a great number of people would know why, and release even more evidence if anything does happen to myself, such as accidental death, a setup leading to imprisonment or similar, that has allowed me to get to this stage.

I have been dismayed by the expense and resource spent on such Equality and Diversity Training within the civil service. When I investigated this recently I was disappointed to discover that civil servants spent thousands of hours of their taxpayer-funded time last year attending lectures on unconscious bias training, on 'micro-incivilities', different 'lived experiences' in 'oppressive systems', and 'how to be a straight ally', courtesy of **Stonewall**. They are referred to so-called experts on white privilege. They are told that if an ethnic-minority person says that something is offensive, then it is offensive and they don't have a right to question it. This is despite a January 2020 ministerial directive that unconscious bias training would be phased out in departments.

This kind of thinking does nothing to create solidarity and encourage support but rather keeps emphasising difference, creates a sense of 'otherness' and pits different groups against each other. It is tearing up the fabric of our society.

And aside from how divisive it is, how the voters in my constituency of **Fareham** would consider this to be value for taxpayers' money is beyond me.

All of this finds its roots in the legal and political turn that was taken in the incorporation of the Convention, through the Human Rights Act and misinterpretations of the Equality Act. They marked a breakaway from the distinct constitutional and human rights tradition of Britain founded on parliamentary sovereignty and democratic oversight.

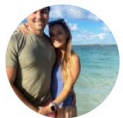
